When we were there, not once or twice we slept hungry. My mother decided to look for a job and she was employed in a certain water company in the village. We thought that poverty had left us but we were really wrong. In January 2008, my mother was suspended from the very job, we were depending on. This was painful because we had no otherwise. Later, my mother was employed as a maid for one year.

In December 2009, she came to look for a job here in Molo, and she is now a matatu tout. After staying in Molo for one year, she came for us at home in Ngong where we lived with my grandmother. When we came here, we settled in a house which we pay ^{after} every

Month. Sometimes, my mother has to give exures to the landlord, because she earns a wage of one hundred and fifty shillings, and yet she has four children to cater for. For example, she has to pay school levies for us, buy food, pay rent and other basic needs. My mother likes farming, but she has no money to hire a piece of land, and buy seeds. She has many debts because the money she earns is not sufficient to cater for all the needs in our family. I usually pity her but I have nothing to do.

While in school, I face many challenges. Example, my mother can not afford to buy me revision books, and so I have to borrow from my fellow pupils although some are very envious of me. My highest marks in class eight is three hundred and twenty two (372). I would be glad if I get a sponsor in my secondary education. This is because my mother doesn't have anywhere to get money for my secondary education, and if I don't continue with my education, my dreams of becoming a pilot will have been shattered. So, I humbly pray to God that you hear my plea and help me. By so doing, You will have brought help a tomorrow strong leader who you'll be proud of. Please, Please, Please, I humbly ask you to help me and one day, I will stand and tell people my story of a future strong leader.
