The so called father left the other family and the house they had rent has been locked due to lack of payment.

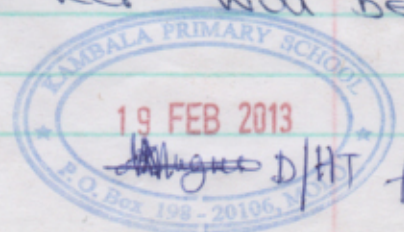
